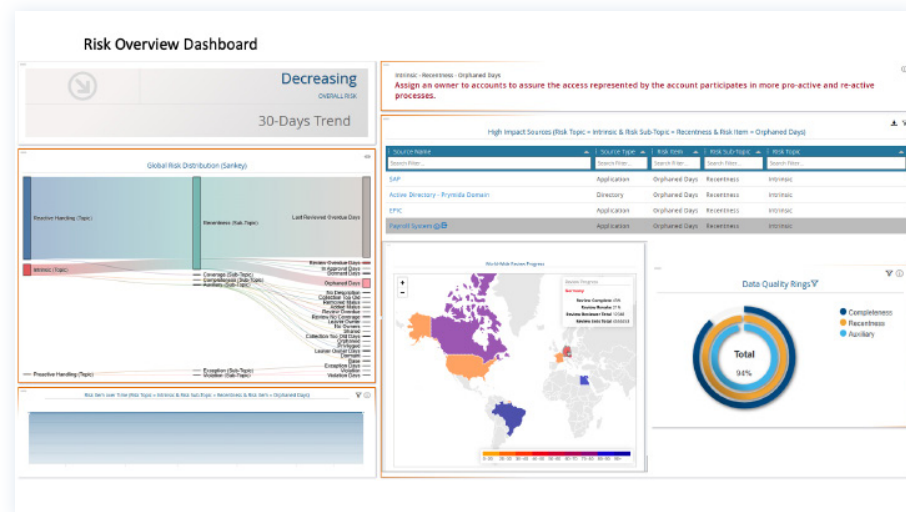

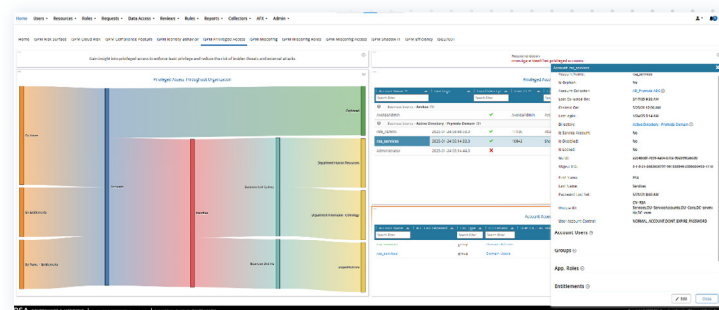

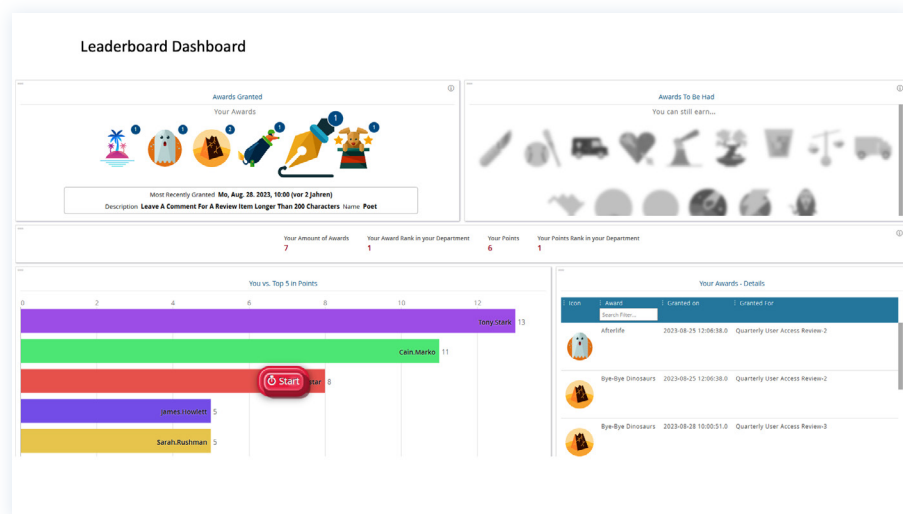
This ISPM dashboard provides insight into privileged access to enforce least privilege and reduce the risk of insider threats and external attacks.

Encourage compliance through gamification

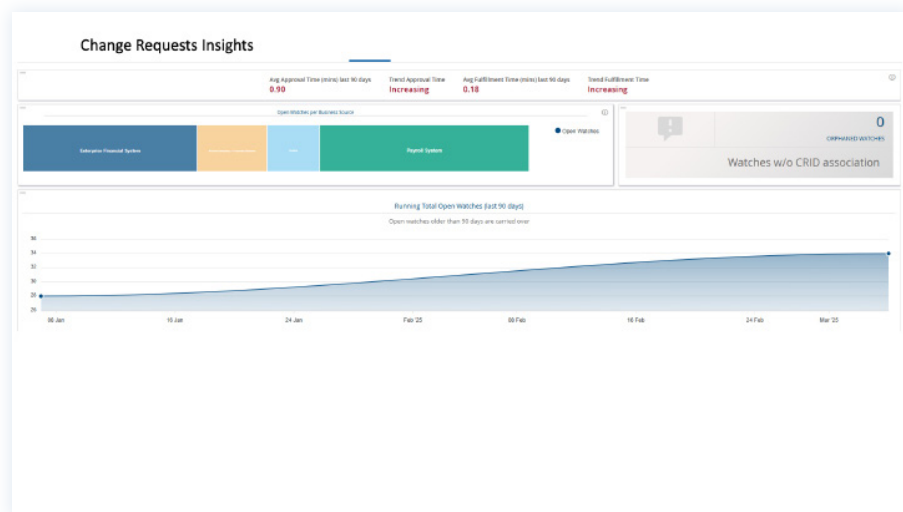

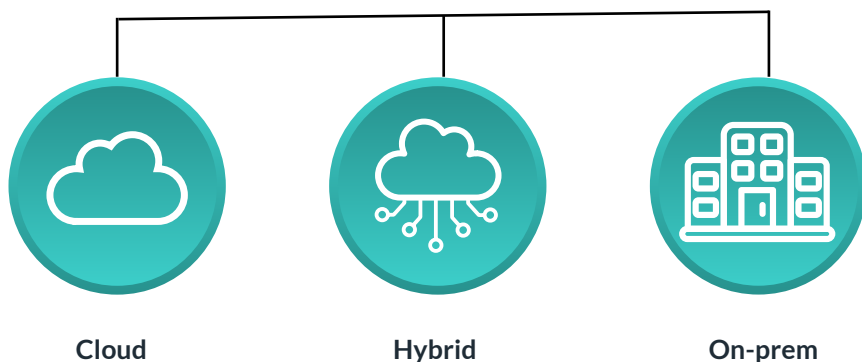
